Report

As the 9th Annual Forum of the EU Strategy for the Baltic Sea Region in Tallinn has come to an end, and we would like to present the key takeaways from the presentations and the discussions that took place during the event. Issues of digitalization, protecting the Baltic Sea environment, and integrating the EU SBSR into the new European financial instruments were at the forefront of the Forum, and the report focuses on the main conclusions drawn as regards those challenges and the post-2020 future of the BSR cooperation. The report provides an overview of the plenaries and seminars held in the framework of the event.

The opening and the first plenary of the 9th EUSBSR Annual Forum focused on taking stock of the achievements in the area of regional cooperation in the BSR, as well as the future of the BSR post-2020 – how the EU Cohesion Policy and the EU Strategy for the BSR can adapt to future challenges.

The Prime Minister of Estonia stressed the main aspects of the BSR cooperation after 2020: digitalization, protecting the environment, integrating the EU SBSR into the new EU financial instruments. Mr Jüri Ratas called for the region to become the model for digital governance based on the free, efficient and truly private flow of data between the people and authorities in the region. Mr Ratas emphasized the need to remain flexible in allocating funds for the regional priorities and focused on relevant common activities.

The Prime Minister of Latvia noted the need for the BSR countries to work further on accomplishing the EU Energy Union goals. Rail Baltic was mentioned as the most important infrastructure project in the region. Prime Minister Kucinskis also emphasized the role of digitalization in further cooperation, specifically through regional centres of innovation excellence and the Nordic-Baltic collaboration in developing 5G network services. Convergence between different BSR states, according to Prime Minister Kucinskis, is no longer possible without the digital solutions and infrastructural connections.

The Prime Minister of Lithuania emphasized the synchronization of the Baltic electricity grid with the continental grid as one of the topical challenges. Prime Minister Skvernelis also noted the need to engage citizens and communities with the projects, as well as bring businesses, NGOs and the people together in their framework. The potential of digitalization – including such new technologies as cryptocurrencies and blockchain – was noted for its significance for the region.

The Foreign Minister of Poland highlighted the fading trust and security concerns related to the Russian Federation. As regards digitalization, Foreign Minister Czaputowicz emphasized the creation of a coherent digital ecosystem, development of the 5G infrastructure and free data flow as necessary precursors for increasing the united competitiveness of the region.

The EU Commissioner for Regional Policy elaborated on the expectations related to the Multiannual Financial Framework (MFF) negotiations and the post-2020 EU SBSR. Commissioner Cretu urged the BSR stakeholders to consider that the macro-regional strategies should be implemented not only with the help of Interreg funds, but that local and regional funding should be mobilized to ensure success of the strategy.

The first plenary panellists brought forward several topical issues and concerns related to the post-2020 BSR. One suggestion mentioned concerned revising one of the 3 Nos and advocating for a special budget allotment in the framework of the MFF negotiations. Expected cuts in cohesion funding for all the BSR states might affect convergence inside the region in a negative way, according to the panellists. The issues of lack of political leadership, complexity and bureaucracy were also cited as hurdles on the way to a truly connected BSR. Flexibility in securing funds (finding alternative sources, such as the Integrated Territorial Investment) and decision-making (multilevel governance) as well as re-defining the image of the cohesion policy as a no-return investment were emphasized by the panellists.

Report

This plenary session was dedicated to exploring the digital opportunities under the title 'A coherent digital Baltic Sea Region'. The Vice President of the European Commission noted that, digitally speaking, the region is well-placed to embrace technological progress. However, there are big disparities between the Nordics and the other countries, and while the divide is not unusual in the EU, Vice President Ansip urged the BSR states to not let it widen. Vice President Ansip emphasized that everybody should have access to high-speed internet, including 5G, and urged the European governments and industry and business representatives to match the level of commitment to digitalisation set by the EU.

The findings of the 'State of the Digital Region' report were presented. Key policy recommendations included shifting education focus from adopting technology to adapting to technology; tackling dual job polarization inside and between BSR countries; an institutionalizing life-long learning in education. It was also mentioned that a way to link BSR countries and provide smooth data availability should be found for the region to achieve yet unmet goals set at the EU level. The Digital North initiative, according to the panellists, plays an important role in strengthening the region as a digital hub. The panellists reiterated that the strongholds of the region are education, people, technology and a stable political climate. Thus, the cooperation should focus on upholding and improving these strengths.

The results of the first version of the 'State of the Baltic Sea' report showed that although there have been signs of improvement in some cases, the Baltic Sea Action Plan's goals and ecological objectives have not been achieved. The panellists agreed that the Baltic Sea is at its limit in terms of human impact and urged the BSR countries to link the HELCOM Baltic Sea Action Plan and the EUSBSR priorities. Political recommendations also included developing regulations for reducing the by-catch and improving monitoring and reporting. The panellists also reiterated the need to solve the problem of plastic waste by withdrawing single-use plastic from the market. Additionally, cooperation between national and regional levels should be prioritized, according to the panellists. As regards eutrophication and agriculture waste, the panellists noted that the BSR already has a holistic assessment system and political regulations in place — it is only enforcement that lags behind.

All speakers agreed that it is highly unlikely that a good environmental state will be reached in the BSR by 2021. The main challenge lies in the fact that problems keep changing (with microplastic and pharmaceuticals being topical in terms of pollution at the moment), while the political will fails to address them with enough ambition and in a timely manner. The panellists also called for more honest

communication between the policy makers and the agriculture and fishing sector representatives on the environmental impact of both in the BSR.

Video: Welcome to Gdansk 2019!

Undersecretary for European Affairs of Foreign Affairs of Estonia Matti Maasikas summed up the main issues and challenges discussed during the forum. Proposed cuts to the Cohesion funds, a smooth decrease in funding and the level of national contributions of the BSR states are expected to become subjects of active debate. Undersecretary Maasikas urged the public to get acquainted with suggestions and policy recommendations for the future of the BSR in the report 'EUSBSR after 2020: governance remastered?' The main suggested solution concerned invigorating the political will through reviving the Steering Groups. Undersecretary Maasikas also recognized the need to further modernize the BSR economy, especially through development of the 5G infrastructure.

Director of the Baltic Development Forum Flemming Stender emphasized the central role of digitalization in all debates of the EUSBSR forum. Although a truly cross-border digital region has not yet been created, according to Director Stender, digitalization remains an important tool for bridging the gap inside the BSR and advancing the European digital single market.

Deputy Marshal of the Pomorskie Region Wieslaw Byczkowski noted that the next forum will focus on issues of demographic change and challenges to the circular economy.

During the seminar, the report 'EUSBSR after 2020: governance remastered?' was presented. The report focuses on how the work is organized to implement the 'Save the Sea' objective by taking a closer look at flagship projects and their realization. The aim of the report was to reflect on the current implementation of the EUSBSR and provide recommendations vis a vis future trends. The report made several proposals, including thematic partnerships, use of existing funding via CPR Art. 70 and macro-regional integrated investments.

The last proposal is based on ITIs in ESIF. Several points were made in the ensuing debate. First, a suggestion to more deeply study what is being implemented in the EUSBSR and BSAP was mentioned. A desire for the Forum to have political consequences was expressed. The use of ITIs was seen as an interesting idea which would make for a change to the system. Another suggestion consisted in considering the question of which ministry should be responsible for macro-regional strategies.

Joint spatial planning perspectives for increasing the share of renewable energy in the BSR are expected to form a strong contribution to cohesion policy and smart, sustainable and inclusive growth after 2020. Currently there is no joint transnational consensus regarding the definition of spatial planning criteria for defining the most suitable places and growth areas for renewable energy (this being the aim of the BEA-APP project). Taking into account important pillars in the planning of renewable energies (economy, society, conflict and transnational cohesion), the seminar presented examples of land-based spatial planning and Maritime Spatial Planning.

In the second part of the seminar, the panel discussed how capacity in BSR countries can be improved to steer the growth of renewable energy production and use in a spatially compatible manner. Two major questions were discussed in regard to territorial cohesion through spatial and energy planning: what major challenges have we met, and how far can we go? The results of the seminar are to be integrated in the outcomes of the EUSBSR horizontal action Spatial Planning flagship project BEA-APP.

The seminar featured a welcome address by Mr Ricardas Degutis, Vice-minister of Transport and Communications of the Republic of Lithuania. In his presentation Vice Minister stressed that development of the TEN- T Core network corridors will increase attractiveness of all countries in the BSR. At the same time, he noted, it is important to develop "hubs" approach with emphasis on multimodality and on interoperability of different modes. Ms Maria Öberg presented innovative ideas on wide involvement of business, regional and local stakeholders in the TEN-T Core Corridors network implementation. Ms Ulrike Schütz dedicated her presentation to Urban Node development, elaborating on such topics, as last mile connection, commuter traffic, ticketing, green mobility, integration of smart solutions, civil acceptance and communication. Mr Jan Carsten Gjerlow stressed that regional and local decision makers will become more important as the main driver for shifting to alternative fuels in the near future. In his presentation Mr Gunnar Platz highlighted the importance and future role of TEN-T corridors and the inland waterway transport.

In his concluding remarks Thomas Erlandson, Coordinator of the Transport Policy Area of the EUSBSR, stressed that deployment of new technologies and innovations on regional transport network will enhance the overall efficiency of the TEN-T network in the Baltic Sea Region. At the same time, the new technologies and innovations will contribute to territorial cohesion and sustainable growth as well as to the EU's green transport policy.

In his key note speech, Mr Mikk Tarros, Vice President of the Estonian National Youth Council, touched upon the need for human coordination in using digital methods; constant promotion of digital participation possibilities; youth-friendly, relevant, comprehensive information; and, ultimately, meaningful participation. Consequently, the panellists discussed the need to involve youth in policy-shaping processes. Additionally, it was noted that communication is crucial — messages should be short and engaging to ensure youths' participation. This participation should also be mainstreamed (not an add-on), according to the participants. There is also a growing need for skills in youth and digital engagement.

The seminar ended with the presentation of a joint youth statement from BSSSC, ERB, LSU and UBC, based on the following points:

- Youth want a fixed role, place and influence in the EUSBSR after 2020;
- Youth are writing the 'Baltic Sea Youth Declaration' — a living document using digital tools — so that ALL youth of the BSR have the opportunity to contribute.
- The EUSBSR must use the Baltic Sea Youth Declaration as a foundation for policy work in the youth area.

The seminar presenters and panellists looked into the following questions: What new/other kind of funding mechanisms already exist or should be developed in the coming programme period post-2020? Could the existing Managing Authority networks of the ESI funds be used? What other components are essential for regions to design things jointly? Discussion revolved around what is needed at present to make cooperation on S3 more effective in the Baltic Sea Region. It was followed by a more detailed exemplification of how to make use of the ERDF MA Network (case: Blue Growth or Digitalisation). Finally, discussion on how the ESF funds could be used to increase the capacity of regions and regional stakeholders to work inter-regionally took place.

Energy consumers — the focus of the seminar — are at the heart of the Energy Union and the EUSBSR PA Energy. The development of innovative and smart technologies in the energy field is stimulating the energy system's transformation towards smarter, more flexible, more sustainable, secure and competitive ways of delivering energy to consumers. The changes in the energy system form steps that are being taken so as to be closer to the EU targets for post-2020. A live demonstration of an exercise in the Seaplane Harbour. All the manoeuvres were professionally narrated and explained by the moderator (from Germany). Four flagship initiatives contributed to the sessions: ChemSAR (PA Safe), HAZARD (PA Secure), DiveSMART Baltic (PA Safe) and Balex Delta (PA Secure).

The main topic discussed during the panel discussion was the need for exercises and their importance. Presenters focused on the positive impact of various exercises, such as opportunities to

At the seminar the organisers presented the new report 'Baltic 2030: Bumps on the Road — How the Baltic Sea States are performing on the SDGs'. The report, introduced by Esben Lanthén, analyses the performance of the BSR countries (including Iceland, Norway and Russia) on the 17 Sustainable Development Goals (SDGs) and explores in depth five of the most challenging ones. Interesting discussions concerned the future of the EUSBSR — the need for the new Baltic Sea Action Plan to be strongly anchored to the 2030 Agenda was highlighted.

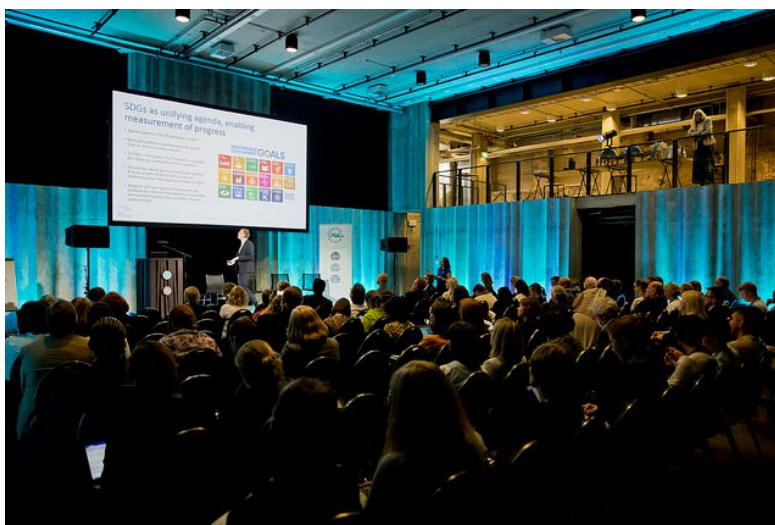

The SDGs shall become a framework but also a tool for macro-regional collaboration, in support of countries' and the EU's efforts to achieve the global goals. It is also crucial to increase the involvement of stakeholders and especially of the businesses, which play key roles in the shift towards more sustainable economies, according to the panellists.

The main conclusions from the seminar were that GHG emissions from growing freight and passenger transport could be curbed by modal shift, use of alternative fuels and zero-carbon vehicles. Mainstreaming climate into transport sector planning will save lives, money and the environment in the BSR and the Paris Climate Goals can be achieved only with the interaction and joint effort of all stakeholders.

panel discussion attempted to answer such questions as: how can we work with talent in the BSR? Is there scope to develop a joint ecosystem to improve talent management? If so, what elements of talent management ecosystems should we design jointly? The discussions also looked into the ways to connect cities to talent producers (universities, hot hubs, etc.) and explored the new types of partnerships (between cities, universities, hubs, etc.) for all cities to become attractive alternatives as bases for talent. The need to find a way to keep talent in the region and compete effectively with global leaders in talent management was emphasised.

Seminar 4. How to make the best use of Interreg programmes in the Baltic Sea Region post-2020 for the benefit of the EUSBSR

In the seminar, four panellists, namely a member of the Interreg Baltic Sea Region Programme's Monitoring Committee, an EUSBSR National Coordinator, an EUSBSR Horizontal Action Leader and a flagship leader presented their proposals on "how to cut the cake" of Interreg Programme funding after 2020 for the benefit of the EUSBSR. The panellists agreed that there is a need for financial support for the work of the PACs/HACs. Joanna Przedzrymirska from the Maritime Institute of Gdansk asked for more support for capacity building for people on the ground to take responsibility.

When it comes to funding for projects, there were different views about differentiating between flagships and non-flagships. Jens Kurnol and other panellists expressed the need for more flexibility in terms of duration and size of cooperation projects. "Why not consider projects as short as one year or as long as five, and applying only for EUR 50,000 up to EUR 5 million?" Jens Kurnol asked. Pointing out to the limitations of projects, Erja Tikka, EUSBSR National Coordinator of Finland, raised another point: "How can processes be funded within the Strategy which take longer than a single project?" All panellists saw the need to continue maritime cross-border cooperation in the region as this serves the specific needs of the region.

The seminar presented the results of the BONUS SHEBA project, which produced a lot of unique data showing the contributions of shipping to air pollution and contributions to loads of contaminants in seawater, as well as maps of shipping-related emissions of underwater noise and assessment of the impact of these pressures on marine life, land ecosystems and human health. A number of future scenarios have been assessed in terms of the impact of different policies and technical abatement measures on reducing the negative environmental impact caused by shipping. The seminar placed these results in the context of the environmental status of the Baltic Sea and the HELCOM Baltic Sea Action Plan, also through discussion between experts from the BONUS SHEBA project, HELCOM and shipping industry stakeholders. Through an interactive dialogue the panel sought a pathway to a sustainable and competitive maritime sector in the Baltic Sea Region for the coming decades.

Presenters focused on the current state of the Baltic Sea and the implementation of HELCOM Baltic Sea Action Plan. The HELCOM 'State of the Baltic Sea' report for 2017 shows that the goal of the Baltic Sea Action Plan (BSAP) and the EUSBSR – the good ecological status of the sea – has not yet been reached. Many of the actions of the BSAP have already been implemented by some countries, but not all, and the remaining ones will have to be accomplished by 2021. At the same time, the HELCOM Ministerial Meeting on 6 March decided on the update of the BSAP for the period beyond 2021. In the seminar, HELCOM received feedback from a panel consisting of representatives of the European Commission, HELCOM Contracting Parties, NGOs, IGOs and parliamentarians on how the update of BSAP should be organized and who should be involved. The panellists highlighted inclusiveness in the process as well as prioritizing the existing commitments.

Seminar 9. Digitalising and connecting the neighbourhood: solutions for the BSR

The speakers introduced and analysed digitalisation trends and cooperation potential. In this context, Peyman Khodabakhsh (Atene KOM) established the picture for the discussion during the session by claiming that one needs “digital infrastructure”, “digital skills” and “digital services” to prepare the regions for the digital world after 2020. Other experts from around the Baltic Sea Region provided their insights and experiences to this topic. Lars Ahlbäck, CEO of Tilaajavastuu, addressed the topic of “digital services” by presenting the joint transnational platform for data sharing and building trust in the real estate and construction sector.

Jury Vorotnitsky, Chairman of the Board for Digitalization Transformation of the Belarusian State University, looked into the “digital skills”, where development of master programmes in the field of complex integrated system design prepares much-needed future skilled personnel. Svetlana Kochkaeva, Manager in the Center of Science and Technology Foresight at ITMO University in St. Petersburg, drew attention to the macro perspective and explained that one has to be aware of different possible futures. It seems the strategic collaboration on global challenges will play a role if we are to maintain the successful development of the region. To illustrate how the knowledge and examples can be implemented locally, the case of city of Turku was examined. The speakers made their recommendations to the developers of the Turku region, which could be summed up as widening the platform and improving the environment for innovation and “smart” development, enabling the data flow between departments and authorities in public administration, and encouraging global thinking, “crazy ideas” and local acting.

Keynote speakers addressed the current state of play in the EU transport sector's responses to the challenges posed by new goals for GHG mitigation and discussed how to improve cross-border and transnational cooperation on adaptation and to increase the resilience of the sector to risks related to climate change.

The seminar contributed to the EUSBSR Annual Forum discussions on 'After 2020' by discussing opportunities and proposing ideas on how to further mainstream mitigation and adaptation within the EUSBSR and how to finance integrated climate actions in the EU MFF post-2020. It also contributed

to the AF main theme Marine Environment as low-carbon transport in the BSR has a less negative impact on the Baltic Sea environment.

The key note made an argument for understanding macro-regional strategies as a tool supporting the project-to-policy loop in an experimental way — providing opportunities for mutual learning inside, but also between the four macro-regional strategies of the EU. Panel discussants explored these ideas even further and came up with five bold statements:

- First, there is a need to have both a process and a project to bring macro-regional strategies to bear.
- Second, political will remains decisive — and it might be desirable to conclude at least some of the annual fora with a declaration of prime ministers. Meetings of sector ministers from all countries of the EUSBSR were highlighted as important.
- Third, a wider range of relevant stakeholders needs to be activated to make macro-regional governance more inclusive — e.g. from the business community.
- Fourth, a more prominent role for steering committees is needed to guarantee the success and sustainability of the Strategies.
- Fifth, the indicators must be more tailor-made, taking into account that strategies deliver on both processes and projects.

Finally, it was concluded that the mutual exchange between stakeholders and implementers across all EU macro-regional strategies remains an important element. Initiation of thematic exchanges across the Strategies by the Interact III Programme are highly appreciated.

In a keynote speech, Mr Dmitry Frank-Kamenetsky (HELCOM) provided a quick overview of the recent HELCOM nutrient input assessments, explaining the sources of nutrient loading and progress towards national reduction targets. Four innovators presented their solutions for reducing eutrophication in short pitch-style presentations. These snapshots reviewed recent innovations that can contribute specifically to reducing eutrophication and thereby to the vision for the Baltic Sea in and beyond 2020, if applied across borders:

- Ms Mari Heinonen (HSY) introduced Case RAVITA, revealing a method for the large-scale recovery of phosphorus and nitrogen from wastewater.
- Ms Silja Kana (WWF Estonia) illustrated how consumers can reduce the ecological footprint of their diet with the help of WWF Meat Guides.
- Ms Elis Vollmer (Estonian University of Life Science) presented ongoing work to develop new manure standards to improve nutrient recycling and reduce nutrient leaching.
- Ms Anna Saarentaus (John Nurminen Foundation) explained the idea of gypsum amendment of agricultural fields – a method which remarkably reduces phosphorus loads instantly.
